Berkeley	Fall instruction began on August 26. Berkeley has decided to begin the fall semester with fully remote instruction. Berkeley is providing \$4.6 million in support for students who will attend class, do assignments and take tests from home — but who lack reliable laptops, Wi-Fi and other technology.	Berkeley plans to house up to 2,000 students in UCB on-campus residence halls in single rooms. Students who wish to cancel their existing on-campus housing contract will receive a message explaining how to do so without penalty.
	Planning for the spring semester will be very similar to that of the fall semester. Students will not be required to take in-person classes or to be present on campus for the spring semester.	
Davis	Fall quarter begins on September 28. UCD plans to offer a mix of in-person and remote instruction. All classes with enrollments greater than or equal to 50 students will be taught remotely. For classes with fewer than 50 students, in-person instruction may be possible. Details on UC Davis' "Campus Ready Plan" can be found here .	On-campus residence halls will have reduced density, and dining commons and other food services on campus will operate in a way that complies with public health requirements for physical distancing and food safety.
Irvine	Fall quarter begins on September 28. Almost all undergraduate courses will be delivered in a remote format. A few exceptions are being evaluated.	UCI will have space for students in single and double rooms. The rooms have been modified to accommodate current public health guidance including the addition of room dividers and increases to cleaning and sanitation schedules. Student housing is at 43% capacity, or about 6,600 students.
Los Angeles	Fall quarter begins on September 28. UCLA will be moving to remote-only instruction for the fall, with the exception of a limited number of in-person or hybrid courses necessary to train students for essential workforce positions.	Under the new county health department directives, universities including UCLA must limit on-campus housing to:
		 Students who have no alternative housing options and whose current housing does not provide a safe and appropriate environment or does not provide sufficient ADA accommodations; Student-athletes participating in on-campus training and conditioning; and Students enrolled in the aforementioned in-person or hybrid courses who do not have alternative local housing options.
		These changes will necessitate a significant reduction in our proposed number of residents at UCLA.

Merced	Fall instruction began on August 26. Merced is open on with a predominantly remote model for instruction. While plans are subject to change based on recommendations from local and state public health officials, as of July 21, the decision has been made to make nearly all courses remote for at least the first four weeks of the semester, with the exception of graduate research which can be performed under strict health and safety protocols.	Priority for campus housing this fall will go to incoming freshmen, housing-insecure students, foster and former foster youth, and our students with an ADA accommodation request.
Riverside	Fall quarter begins on September 28. Instructors for all lectures, discussions, colloquia, seminars, workshops and other similar course types are preparing to teach remotely in fall quarter. Undergraduate research also must be conducted remotely in fall. UCR has approved a small number of laboratory and studio courses to meet in person, with remote options for students who prefer not to participate in person, according to local and state public health orders. Remote learning will continue until Fall 2021.	UCR will have on campus housing available, but the density will be lower than normal and is still being determined. Under normal conditions, UCR would have over 4,200 students living in residence halls. For this fall, UCR expects approximately 1,400 students to be living in modified residence halls, with one student per room.
San Diego	Fall quarter begins on September 28. UCSD has arranged to offer over 4,750 lecture, lab and discussion course sections, 30% of which will be conducted in person and 70% in a remote or hybrid format, for both undergraduate and graduate students. In-person class size is limited to fewer than 50 students per class, or 50% of classroom capacity, whichever is smaller.	Approximately 7,500 undergraduate students will be living in single occupancy rooms for the fall quarter, with double- and triple-occupancy housing options eliminated to reduce housing density. About 4,000 graduate students will also be living on campus, with single graduate students housed in single bedrooms. Students who are eligible for a two-year housing guarantee and completed the housing application by the deadline will be offered a housing contract for the 2020-21 academic year.
San Francisco	Fall quarter begins on September 9. All didactic and discussion-based classes in the summer and fall quarters will be planned for remote delivery. All co-curricular, extra-curricular, orientation, and social activities that can be, will be facilitated remotely.	The self-reporting policy remains in effect for anyone living on campus. Should Housing Services be notified of a resident testing positive for COVID-19, they will offer resources, including alternate temporary housing to protect other lease holders within that shared unit.

Santa Barbara	Fall quarter begins on September 27. On August 28 th , UCSB decided to offer nearly all undergraduate fall courses via remote instruction for the fall term with limited exceptions. UCSB recommends that all undergraduate students stay home to receive remote instruction.	UCSB campus leadership has decided that all undergraduate residence halls and apartments will be closed for the Fall Quarter. Students that believe they have special circumstances that require them to live close to campus for the Fall Quarter were able to submit a request to be considered for an exception. Students with current valid housing contracts will have their start date amended to begin on January 3, 2021 (subject to change), contingent upon us receiving approval to reopen our facilities in Winter Quarter.
Santa Cruz	Fall quarter begins on September 26 (instruction on October 1). Santa Cruz will offer remote instruction and only offer in-person instruction where it is pedagogically necessary and can be done in a manner that attends to University and public health guidelines. The vast majority of course enrollments will be for remote and online instruction.	Students in residence halls will be in singles, while campus apartments will be a mix of single and double occupancy. Due to COVID-19 and recent wildfires threatening the Santa Cruz campus, UCSC can only accommodate a small number of students and are encouraging everyone to spend fall quarter at their current residence, if possible.
